Legislative Update

With a short legislative session and rulemakings as a result of the session, it has been a busy first part of the year.

OTA has been meeting with legislators and candidates as well in an effort to educate them about our priorities for the legislative session in 2019. Here is a brief re-cap of what we have been working on. As always, please just give me a call or send along an e-mail if you have any questions or concerns.

February Legislative Session – you might recall that when voters passed the ballot measure mandating legislative sessions each year, the short session in even numbered years was supposed to be dedicated to addressing fiscal emergencies and other pressing state business. Well, the fear that some folks had – that once in session all manner of issues would come up – certainly was realized this past February.

This was the most difficult session for us in many years. Two separate bills were signed into law over the objections of OTA and all other telecommunications industry groups. The first, House Bill 4155, dealt with net neutrality. Realizing that our members do not engage in the prohibited activity we only wanted to ensure that we could continue to provide service to state agencies. Oregon law now states that entities that do business with the State of Oregon are prohibited from traffic shaping, throttling, re-directing traffic, etc. OK, fine by us. The rulemaking at the OPUC has gone well and our members will be able to deal with this mandate without any undue burden.

The second bill, House Bill 4023, was much more troubling and is proving more difficult to deal with. Briefly, it allows the State of Oregon Chief Information Officer (OSCIO) to provide broadband service, defined as 25/3, to non-state entities such as schools and libraries if no broadband service is available to them. OTA's objection was and remains pretty simple: no state-owned facilities should be used to overbuild existing facilities and strand investment that our members have made.

Legislative Continued...

The bill also directed that a committee be created to write the rules for this law. OTA, CenturyLink and others are on the committee. While the telecommunications folks have gotten concessions and are making good progress, there remains aspects of the rules that are troubling. For example:

Our position is that the state should only consider providing service in unserved or truly underserved areas. Other parties disagree.

Our position is that having access to broadband and having access to affordable broadband is site specific and two very different things. In other words providing service in some areas is way more expensive in some areas than in some other areas. Other parties disagree.

You can see where this is going. OTA is working closely with our industry partners and in particular our friends in the cable industry to address these concerns. The rules are not going to be perfect but, I feel there will be language included that will make it mandatory that non-state entities have to provide proof that they contacted all local service providers and were told that no service was available at the specific location in question.

In addition to all that, we have been meeting with legislators to socialize our effort to ensure that the contributions to the Oregon Universal Service Fund are non-discriminatory and all providers contribute as our customers have contributed over the years. We are meeting with some good results and there is a real possibility that we might be successful in this effort. Meeting with Senators and Representatives in their districts is important and I really appreciate everyone who has been able to help out and meet with these elected officials. We will continue this effort until next year and just continue pressing our story.

Our legislation, which will be introduced in 2019, will eliminate the exemption from contributing to the fund that the wireless carriers have enjoyed since the Oregon USF program began. There are other elements to the legislation, such as creating a broadband grant program, that are making it easier for some folks to support the effort. While gaining support for a new fee is really difficult for some officials to get behind, we are making a solid effort and will simply continue to tell our story.

Outside Plant Seminar 2018...

took place on the beautiful Oregon Coast in Newport at the Best Western Agate Beach Inn on April 26 – 27. The two-day event was attended by 71 people. 15 vendors participated in this year's conference.

Kicking off the seminar, back by ever popular demand was **Chris Robertson** from **Three Wolves Consulting**. Chris has a wealth of knowledge and experiences to share and we are always pleased when he has the time to join us! This year he provided two sessions for our conference, "Testing Copper Facilities for XDSL Services" and "VDSL 2 Vectoring." Chris detailed the electrical tests that should be performed during the installation and maintenance of DSL services, covering Bonding, Vectoring and G.INP. He also talked about how vectoring operates, the effectiveness of Vectoring and binder group loading limitations.

Brant Wolf, OTA's EVP offered another of his legislative and regulatory updates speaking to this year's short legislative session and the unusually active participation for OTA relating to Net Neutrality, a state owned and operated fiber network and tax credits for gigabit projects. He also discussed the serious moves by two counties to build out and offer telecommunications services in Oregon.

The Outside Plant Employee of the Year Award was presented during the buffet lunch. The recipient of this award for 2018 was **Ron Stenger** from **DirectLink**. Ron began his employment with Canby Telephone Association in 1985. In his 33 years as a field inspector he has seen a lot of change within the telecommunications industry. During the past 9 years Ron had held a seat on the OUNC (Oregon Utility Notification Center) Board of Directors representing telephone cooperatives for utility damage prevention. Ron has been an instrumental part in developing and maintaining the Oregon 811 notification that we all use today. **Congratulations Ron** — thank you for your commitment and many years of service to this industry.

Dave discussed best practices, challenges and tips to address these WiFi opportunities to provide quality service to the existing community and how to grow revenue with businesses and public venues.

Tanner Betteridge, Director of Safety at **North Sky Communications** addressed codes, standards and best practices for General Road Side Safety during construction and the standard road side sign set up for the state of Oregon.
